## Allegations:

- 1. Using East Baton Rouge Council on Aging (EBRCOA) money for political purposes. <a href="https://www.businessreport.com/business/allegations-council-aging-illegally-involved-promoting-tax-november-election-raised-questions-prompted-probelegislative-auditor">https://www.businessreport.com/business/allegations-council-aging-illegally-involved-promoting-tax-november-election-raised-questions-prompted-probelegislative-auditor</a>
- 2. Violating State of Louisiana ethic laws. On July 7, 2016 the director of EBRCOA, Dytashia Clark-Amar and one board member Dorthy F. Jackson (attorney), helped Helen Plummer with her will. Ms. Jackson was the attorney who prepared and notarized Ms. Plummer's will. In Ms. Plummer's will it named Dorthy F. Jackson as attorney for Ms. Plummer's Estate. It also named Ms. Clark-Amar as the executrix. Ms. Clark-Amar in her role as executrix is to be compensated \$500 per month for the next 21 years.

Being that Ms. Plummer was a client of the EBRCOA and that Ms. Clark-Amar is a "public servant", this is a violation of Louisiana Ethics Laws and could almost be considered as Elderly Financial Abuse.
